### Constitution and By-laws

- Devin presented the proposed amendments and moved each for a vote.
- HK1-House Keeping-Amended to extend applicable changes to the Bylaws. Motion adopted as amended via voice vote.
- CA1-Work Site Leaders-Motion adopted via voice vote.
- CA2-Voting Committee-Motion adopted via rising vote: 40 in support, 20 in opposition,
- R1- Vote by mail- Amended to strike language limiting vote by mail to occur only in the summer. Motion adopted via voice vote.

### Bargaining:

Eric gave an update on the Districts proposals. The District told us that we have 544K to divide it up anyway we can. No monies can go towards health insurance. Our survey showed that 36% had to lower or drop their health insurance, 5% has gone through a bankruptcy. 36% are working two jobs. 364 employees are stepped out. 70% are eligible for a step. 100% are eligible for Cola.

It was motioned by Leslie Hatcher from Brown Middle School that since there was not a quorum at the March General Membership Meeting that we ratify the business of that meeting before proceeding with the tonight's voting. It was second and motion passed.
