## Constitution and Bylaws Update

The Constitution and Bylaws Committee has revised the initial list of amendments down to only a handful. These amendments will be discussed and voted on before we move to officer elections. The full text of the amendments are listed on the HCU website and you can find them by navigating to:

This is only the first round of amendments, the committee plans to build a list of amendments to bring to each membership meeting for discussion and approval. The list of pending amendments will be posted on the website, and new amendments shall be posted in the newsletter. Our new amendments are:

- CA1** - Strike all language in Article IV of the HCU Bylaws and amend new language to define Work Site Leaders.
- CA2** - Amend Article V of the HCU bylaws to include a committee to manage voting.
- R1** - Resolution to direct the voting committee to draft policy to perform a vote by mail.
- HK1** - Housekeeping Amendment to improve formatting and wording of Constitution
